In November of 2012, Chanos suffered a major heart attack. His brush with death left him resolved to prepare his daughter and nephew for the future. His desire to share what he believes accounted for his own success, resulted in the 2016 publication of his first book, Seize Your Destiny: Choices That Lead to a Happy, Successful and Meaningful Life. His desire to prepare his family for a future, that he knew would be nothing like his own past, resulted in eighteen months of research and the 2019 publication of Millennial Samurai: A Mindset for the 21st Century.

Chanos served as Nevada's 31<sup>st</sup> Attorney General from 2005-2007, in that role, he administered Nevada's Department of Justice and acted as the state's chief legal officer. He also successfully (9/0) argued — Warton v. Bockting, 549 U.S. 406 (2007) — before the United States Supreme Court.

Prior to serving as Attorney General, Chanos had a distinguished legal career representing individual and corporate clients on all matters relating to growth and management of their businesses.

Today, Chanos resides in Las Vegas as an author, speaker and business consultant. He has served on numerous boards, both civic and corporate and for the last ten years has served as Chairman of Capriotti's Sandwich Shop Inc., with over 100 stores in 19 states, where he advises and mentors his Millennial partners.

Chanos credits 4 core values for laying the foundation for his success – character, courage, commitment and compassion. He then builds upon that foundation by writing about core principals like authenticity, curiosity and choice, that he believes are also essential to success.
